2. Copy of your Michigan Sales Tax License

DO NOT SEND ANY PAYMENT WITH THIS APPLICATION. You will receive an invoice from The City of Dearborn which you will need to pay prior to the event. If payment is not made before event, you will lose your place in Dearborn Winterfest Market.
